Turned around a city in decline by attracting development, building revenues, improving public safety, fixing existing issues and improving processes.

- ❖ From August 2019 to January 2022, assumed Development Services Director responsibilities in addition to City Manager role and significantly increased the level of development activity in the city.
 - Attracted developer for a high-end hotel development project on the waterfront.
